

ANSON CHARITABLE CONTRIBUTION REQUEST SUMMARY STATEMENT

OVERVIEW:

Duke Realty Corporation's mission is to make communities where we do business better places to live. Therefore, Duke has created the Anson Charitable Contribution Program to complement the ongoing Anson development in Boone County. The Program aims to assist financially Boone County organizations that benefit the community.

GUIDELINES:

Duke Realty Corporation makes contributions to eligible not-for-profit organizations based in Boone County, Indiana whose goals are aligned with our strategic interests. Organizations must be tax exempt under the IRS 501(c)(3) and 509 (a)(1), (2), or (3) codes. However, in rare cases, Duke will consider applications from organizations that do not meet the tax-exempt codes. Duke has a strong preference for supporting local organizations, but will consider national sponsorships on occasion. If you think that your organization should be given special consideration, you must make that clear on your application form.

PROCESS:

Your request for a charitable contribution will be more likely to be granted if it is:

- In line with Duke Realty Corporation's mission.
- Beneficial to the Anson project and the greater Boone County community.
- Affordable.
- Designed to make a lasting impact.

On a quarterly basis, the Anson Charitable Contribution Committee reviews every request that meets the established guidelines. The Committee then considers which requests receive funding based on annual budget allotments. Due to the volume of applications that we receive, some requests may be granted for a future year. All requests will be responded to when final decisions have been made after the end of each quarter.
